The Superintendent must maintain integrity and high standards of ethics in all matters. Among other attributes sought, the successful candidate will demonstrate the following major characteristics:

- Work effectively with the board and treasurer
- Be a strong instructional leader.
- Be visible and accessible and an active leader in the community
- Hold people accountable
- Understand school funding
- Make sound data-driven decisions
- Be willing to make difficult decisions
- Communicate well, be a good listener, and be skilled in public relations
- Understand board policies and the law
- Be able to work with others
- Be energetic, passionate and compassionate.

Compensation

The board intends to offer the successful candidate a multi-year, 260-day contract. Salary and fringe benefits will be competitive and will be commensurate with the candidate's education, qualifications, and experience.

The District & Community

Located in Miami County in southwestern Ohio, the district consists of approximately 800 students who attend a one-campus K-12 facility within the Village of Covington. The location offers parks, recreation and dining options, and many small town amenities. The location also provides convenient student access to Edison Community College and the Upper Valley Career Center, and to several quality public and private four-year institutions. Our community is just twenty minutes from the I-70, I-75 interchange and is surrounded by a variety of employment opportunities.

The district offers a core of comprehensive academic programs, including college preparatory courses, college credit plus (both on and off campus), gifted and talented programs, special education programs, FFA, and classes in the fine arts. Students interested in career technical programs can attend the Upper Valley Career Center, located just ten miles from Covington. While the greatest emphasis is on academic achievement, high quality extra-curricular programs play an important role in students' lives as well.
