

2023-2024 ESC-Specific Professional Learning on High-Quality Instructional Materials (HQIM)

The Ohio Materials Matter Initiative focuses on expanding professional learning regarding methods for reviewing, selecting and implementing high-quality instructional materials (HQIM) and increasing capacity among educational service centers, teachers, districts and school leaders to collaborate in the process of selecting and implementing the standards-aligned instructional foundation students need to be successful.

There are several professional learning opportunities specifically created for the Educational Service Center (ESC) Network:

Ohio Materials Matter: High-Quality Instructional Material Webinars for ESCs

For: All ESC staff who want to learn about HQIM and how to support districts with HQIM EdReports will facilitate a series of ESC-focused HQIM webinars that provide ESC staff with information and resources they can use to support districts with the adoption and implementation of instructional materials.

Ohio Materials Matter: Smart Adoption Practices

For: HQIM and Math Specialists at ESCs who did not attend the professional learning series during the 2022-2023 school year

EdReports will work with HQIM and Math Specialists to support smart adoption practices – the training focuses on mathematics, but content will be applicable to other subject areas. These are "train-the-trainer" sessions that will provide guidance and resources to support districts in the process of selecting high-quality instructional materials. Trainings will be beneficial for specialists to support districts with adoptions in the near future, as well as those that will be looking to adopt at a later time.

Ohio Materials Matter: K-8 Math Implementation Cohort 1 & Cohort 2 ESC Collaborative

For: ESCs who have already committed to being part of Cohort 1 or Cohort 2 Instruction Partners will work with ESCs in Cohort 1 and 2 to effectively implement HQIM in K-8 mathematics. Professional learning includes quarterly meetings and a year of support for the district from their ESC and Instruction Partners (including instructional rounds, action planning and professional learning).

Ohio Materials Matter: HQIM Communities of Practice

For: HQIM Specialists and Cohort 1 and 2 ESC Leads

Participants will all attend the first and last sessions, then may select a three-session pathway where they will have an opportunity to collaborate on the creation of customized HQIM tools to support districts with understanding the importance of HQI tools to support districts with understanding the importance of HQIM, managing adoption timelines, and engaging with vendors. These tools with be shared with ESCs throughout the state to promote the use of HQIM.

Ohio Materials Matter: HQIM Specialists' Implementation Series

For: HQIM Specialists

Virtual sessions for HQIM Specialists to build skills implementing HQIM, mirroring the Ohio Materials Matter: HQIM Implementation project with Instruction Partners. Participants will participate in EITHER the Tuesday or the Thursday group.

Ohio Materials Matter: Math Series (TBD)

For: All ESC staff who want to learn strategies to support the implementation of the math standards and practices

A new vendor will deliver sessions throughout the year. Participants will build capacity around implementation of the math standards and practices. This series is in development; more information will be coming soon.

Ohio Materials Matter: Mathematics Standards and Practices Implementation (TBD)

For: Math Specialists

A new vendor will deliver in-person "Train-the-Trainer" sessions for Math Specialists. Participants will learn strategies for working with educators on effectively implementing the math standards and practices, with an emphasis on supporting implementation of math HQIM. This series is in development; more information will be coming soon.
